All dealer tables were paid by yesterday. Various bills still to be presented. Federation is solvent.

### **Youth Activities**

Welt came with 19 students on Friday. Many children today. Not many on Saturday (many children have regular Saturday activities).

## Boston 2026

Feasibility report discussed and approved. Boston 2026 Feasibility Committee thanked and disbanded. Boston 2026 Bid Committee appointed (initially Nancy, Mark, and Yamil Kouri, but others to be added later). Suggestion that we should consider timing of show to coincide with one or more other hobby shows, BCEC is large enough to hold more than one show simultaneously (similar to Olymphex 96 arrangement and Verona show).

## Philatelic Show 2013

- a) Horrible weather (clear blue skys; dry; mid 60s) may have affected attendance.
- b) Mike said most dealers reported a good show (8-bad; 20-good; 29-very good; 16-excellent).
- c) Jack said as of Noon 735 paid attendance + other (uncounted) unpaid admissions (children, exhibitors, judges, committee, etc.). Norm did informal survey of 30 attendees and found 10 were first timers.
- d) For next year, need larger/better signage; schematic of the smaller rooms in the program; more frames (only 220 this show); dealers need programs; need to be able to handle last minute changes to program. Jim Warner moving to Maine. This will leave a big hole on the committee.

- e) Futures Committee studying new show site options.
- f) The Classics Society coming to 2014. United States Stamp Society coming to 2015. Looking to move show to Mother's Day in 2016 (need to coordinate with APS).

# Spellman Symposium

- a) Nancy reported a great success. Good attendance at symposium on Thursday and gala dinner on Friday.
- b) Nice story on Spellman's 50<sup>th</sup> anniversary and FD ceremony in yesterday's Boston Globe.

# **Federation Tax Status**

Mark presented preliminary version of federation's application for 501(c) (4) tax status. Bruce to incorporate financial reporting information. George Norton to provide legal review. To be filed in October after end of current fiscal year.
